PERFORMANCE WORK STATEMENT

Scope of Work: The development of a non-specific chemical toxicity sensor for monitoring water using multiple strains of genetically engineered bacteria. This effort is not to exceed 18 months.

The ability to genetically engineer bacteria has reached a point where it is practical to develop a broad band chemical toxicity sensor for monitoring water. This effort will build upon already existing bacterial genetic engineering capabilities to develop a toxicity sensor for testing drinking water samples suitable for field use having the following characteristics:

1. Engineered bacterial strains characteristics

a. Response to toxicants

- i. Utilize a panel of genetically-engineered bacteria capable of responding upon exposure to at least 14 of the 18 chemicals listed below at or no more than a factor of fifty above the specified concentration; responses to concentrations below those specified are not desirable. Detection levels shall be determined as the lowest concentration at which 16 consecutive assays yield a positive response without an intervening negative response.
- ii. The bacterial strains should be engineered to respond to classes of chemicals (e.g., acetylcholinesterase inhibitors) rather than individual chemicals (e.g., aldicarb, fenamiphos, and methamidophos).
- iii. The bacterial strains should be novel, representing significant advances beyond currently-available technology.
- iv. Response should be readily monitored electronically and should occur within 60 minutes of the initiation of exposure.

b. Response to interferences

- i. Either no response demonstrated or a suitable work-around is available (one that has minimal effect on toxicant sensitivity or test complexity) for the following water characteristics

1. pH (5-10)
 2. Chlorine and chloramine residuals (up to 10 mg/L)
 3. Hard water (up to 250 mg/L as CaCO₃)
 4. Total organic carbon
- c. Storage and shelf life capabilities
- i. Bacterial strains should be selected to allow survival for up to six months at room temperatures (15 to 30°C). Survival for longer time periods and/or at elevated temperatures is desirable. Any other reagents required for testing should have similar viability under equivalent conditions.
 - ii. Survival should be demonstrated in the format selected for toxicity testing (e.g., bacteria stored on test chips, cartridges, etc.)
2. Toxicity sensor characteristics
- a. The sensor system should be a self-contained, hand-held, battery powered unit
 - b. Simplicity of operation
 - i. All necessary data analysis software is contained in the unit and compatible with US standard operating systems for information output.
 - ii. Minimal training required for test operators
 - c. Bacteria and any necessary reagents packaged such that minimal preparations are required prior to testing.
 - d. Bacteria are contained in small, inexpensive (less than \$20 per unit) test chips or cartridges
 - e. Sensor quality control
 - i. Design should include self-testing upon start-up
 - ii. Positive and negative controls should be included; i.e., that will demonstrate that cells are viable, functioning normally, and capable of responding to a toxicant challenge

DELIVERABLES

Deliverables

1. Preliminary schedule of tasks
2. Quarterly technical progress reports including a Gantt chart of task status
3. Proposed design for the prototype test instrument and bacterial chips/cartridges
4. Draft/final report that includes response of engineered bacterial strains to toxicants and bacterial strain longevity (indicating retention of toxicant response capabilities)
5. Provide two prototype test systems and the necessary bacterial chips/cartridges for validation testing at USACEHR.

Quality Control Plan

a. The contractor shall establish and maintain a Quality Control Program and document in a Quality Control Plan, to ensure that all services, specified in the Performance Work Statement, are provided and include timeliness and level of quality.

b. This plan should be submitted to the Contracting Officer within 30 days from award and should be updated hereafter as approved changes occur.

INSTRUCTIONS

Instructions and Notices to Offerors

One Proposal: The Government will evaluate only one proposal from each prime Offeror.

Award on Initial Offer: The Government intends to evaluate proposals and award a contract without discussions with Offerors (except clarifications as described in FAR 15.306(a)). Therefore, the Offeror's initial proposal should contain the Offeror's best terms from both a price and technical standpoint. The Government reserves the right to conduct discussions if the Contracting Officer later determines them to be necessary. (FAR 52.212-1 (g))

Proposal Revisions: Should the Government determine that discussions are necessary; the Contracting Officer will provide proposal revision instructions to the Offerors, as required.

Page Limitation: The Government cannot consider pages submitted in excess of the stated page limitations. Page limitations include all text, graphs, pictures, appendices, references, exhibits, etc. Tabs, index sheets, tables of contents, dividers and other such aids that are solely used to assist the evaluator in locating information and are advisory in nature, imparting no other information other than the identification of content, will not be counted against any page limits stated within this RFP.

Proposal Content: Proposals shall be clear, specific, complete, and concise, presenting complete effective methods and approaches for satisfying the RFP's requirements. Content shall be indexed (cross-indexed, as appropriate) and logically assembled.

Proposal Submission: The Offerors' proposals shall be submitted to the Government as 2 separate volumes each volume on a separate compact disk; (1) Technical and Management to explain required technical efforts and (2) Price Proposal.

Each of the sections shall be separate and complete, so that evaluation of one may be accomplished independently of, and concurrently with, evaluation of the others

Volume II – Price: The offeror shall demonstrate that they have the necessary financial capacity, working capital and other resources to perform this contract without assistance from any outside sources. Price information shall be included in the Price Proposal Volume II **ONLY** and shall not be discussed or exhibited in any other part of the Offeror's proposal.

Additional pages will be removed and will not be evaluated.

Electronic Format Submission

The Offeror shall provide:

Offerors are referred to FAR 52.212-1, Instructions to Offerors – Commercial Items, for general instructions on: submission, modification, revision and withdrawal of proposals; late proposals and revisions; offer expiration date; restrictions on disclosure and use of data; and contract award.

Evaluation of Proposals: The Government will evaluate proposals in accordance with the evaluation criteria set forth in RFP W81XWH-10-R-0142.

An offeror's proposal must stipulate that it is predicated upon all the terms and conditions of this RFP.

EVALUATION FACTORS FOR AWARD

This is best value procurement. The Government may select to award to other than the lowest priced, based on the evaluation of the non-priced factors and the best value to the Government. Proposals submitted in response to the RFP will be evaluated based on the following evaluation factors: Factor 1 Technical, Factor 2 Qualification, Factor 3 Past Performance and Factor 4 Price. An offeror is expected to submit sufficient information in response to the RFP to allow for the evaluation of his/her proposal.

Price will be evaluated separately from past performance and other non-priced factors, and will be evaluated for fairness and reasonableness. As the collective non-priced factors reach equality in the evaluation, price becomes a more important factor in the tradeoff analysis.

Non-Priced Evaluation factors are listed in descending order of importance. Technical and Qualifications are more important than past performance. On the rare occasion that no relevant past performance exists within the offeror's organization or for whom information on past performance is unavailable, the offeror will not be evaluated favorably or unfavorably on past performance but will be treated as a Neutral performance risk. After each of the non-priced factors is rated individually, an overall rating will be assigned collectively to these factors. If any of the non-priced evaluation factors receives an individual rating of "Unacceptable", the collective overall rating will also be "Unacceptable". Only proposals receiving an overall rating of "Acceptable" or higher will be considered for award.

Proposals that are unrealistic in terms of non-priced factors will be deemed reflective of an inherent lack of technical competence or indicative of the offeror's failure to comprehend the complexity and risks of the contract requirements and may be grounds for rejection of the proposal. Offerors are cautioned that the award may not necessarily be made to the lowest price offered.

Ratings consistent with these evaluation factors will be derived from the demonstrated ability of each offeror as represented in his/her proposal, to perform the required work as set forth in the Performance Work Statement (contained in the RFP) and in accordance with all aspects of the RFP.

The Government reserves the right to:

- (a) reject any or all proposals;
- (b) award no contract at all depending on the quality of the proposal(s) submitted and the availability of funds;
- (c) award to other than the lowest priced offer;
- (d) waive informalities and minor irregularities in offers received; and
- (e) award a contract without discussions

Each initial offer should contain the offeror's best terms from a technical and price standpoint.

The Government will evaluate the technical capability of the offerors that submit acceptable offers

Each of the following factors will be rated as follows:

1. Technical. Contractor must demonstrate knowledge and experience in methods necessary to design and produce an array of genetically-engineered bacterial strains with sensitivity to particular chemical toxicants or classes of toxicants. Contractor must demonstrate ability to produce functional prototypes of toxicity sensor systems using bacteria.

2. Qualifications. Contractor must demonstrate ability to design and produce an array of genetically-engineered bacterial strains with sensitivity to particular chemical toxicants or classes of toxicants and to produce functional bacterial-based toxicity sensor devices.

3. Past Performance. Contractor must provide evidence that previous work with bacteria- based toxicity sensors was performed. The offeror's past performance will be evaluated as part of the technical evaluation. In the event an offeror lacks a record of past performance, the lack of past performance will be evaluated as an unknown risk having no favorable or unfavorable impact on the evaluation.

(a) Offerors shall provide documentation showing the degree of relevancy and success in past performance efforts for the past 3 years of a similar scope, size, complexity, and subject matter in accordance with the solicitation.

(b) Offerors shall describe problems encountered in the performance of similar requirements and describe how the problems was/were resolved.

(c) The Offeror shall ensure that all references (3 to 5 references requested) complete and submit the Past Performance Questionnaire directly to the Contract Specialist prior to the closing date of the solicitation. Past performance information obtained by the Government from other sources may also be used for evaluation. The information gathered will be used to assess the relevancy of performance risk involved in accepting each offeror's proposal.

(d) The offeror must follow-up with references to ensure the past performance questionnaires are sent to the Contract Specialist as instructed in the RFP/solicitation.

(e) In the event an established offeror is simply without a record of past performance, the offeror's lack of past performance will be evaluated as an unknown risk having no favorable or unfavorable impact on the evaluation.

4. Price Analysis. The objective of price analysis is to ensure that the final agreed-to price is fair and reasonable and consistent with the effort proposed.

The offeror shall submit information other than cost or pricing data so that the Government may perform a price analysis. Before making the award, the Contracting Officer must determine that the proposed price(s) is fair and reasonable.

When contracting on a firm fixed price, comparison of the proposed prices will usually satisfy the requirement to perform a price analysis, and a cost analysis need not be performed (FAR 15.305(a)(1)).

In accordance with FAR 15.404(b), price analysis is the process of examining and evaluating a proposed price without evaluating its separate cost elements and proposed profit. The Government may use various price analysis techniques and procedures to ensure a fair and reasonable price.

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern," means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and the size standard in paragraph (a) of this provision.

Veteran-owned small business concern means a small business concern--

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

"Women-owned small business concern," means a small business concern --

(1) That is at least 51 percent owned by one or more women or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; or

(2) Whose management and daily business operations are controlled by one or more women.

(d) Notice.

(a) Definition. HUBZone small business concern, as used in this clause, means a small business concern that appears on the List of Qualified HUBZone Small Business Concerns maintained by the Small Business Administration.

(b) Evaluation preference. (1) Offers will be evaluated by adding a factor of 10 percent to the price of all offers, except--

(4) Construction by special trade contractors, at least 25 percent of the cost of the contract performance incurred for personnel will be spent on the concern's employees or the employees of other HUBZone small business concerns.

(e) A HUBZone joint venture agrees that in the performance of the contract, the applicable percentage specified in paragraph (d) of this clause will be performed by the HUBZone small business participant or participants.

(f) A HUBZone small business concern nonmanufacturer agrees to furnish in performing this contract only end items manufactured or produced by HUBZone small business manufacturer concerns. This paragraph does not apply in connection with construction or service contracts.

52.219-22 SMALL DISADVANTAGED BUSINESS STATUS (OCT 1999)

(2)___ For Joint Ventures. The offeror represents, as part of its offer, that it is a joint venture that complies with the requirements at 13 CFR 124.1002(f) and that the representation in paragraph (b)(1) of this provision is accurate for the small disadvantaged business concern that is participating in the joint venture.
